#### **How it Works**

- 1. Choose the items you have to sell that are on our acceptable items list and either ship them to us or drop them off. You can ship items to us and we can go through and take a look at what you have and recommend items to sell.
  - \* We'll select items that meet selling requirements and the items that do not will be shipped back at consignor's expense. If return shipping isn't paid or or if the items aren't picked up within 30 days, the items are forfeited to Tack Hoarders Anonymous (THA).
- 3. We price the items at your asking price or we'll recommend a different price based on the current market.
- 4. All items are consigned for a minimum of 180 days.
  - \* If you decide to remove your saddle at any point, a restocking fee is owed to THA. We will have already cleaned, photographed, safely stored and marketed on our site/social media. Given our time, expertise and best efforts to sell your saddle.
    - \* Removal fee for saddles priced at \$1,500 or less is \$50, for saddles over \$1,500 it is \$100.
      - \*Other items have a removal fee of half of what the commission would have been.
- 5. After 180 days, your contract expires and you can either reserve the right to request the unsold items back or re-list them at a lower price for another 180 days.
- 6. It is your responsibility to keep track of contract expiration (I recommend entering into your calendar now).
- 7. If you do not contact us within 30 days of contract expiration, the unsold items are forfeited to THA and may be dealt with as THA sees fit. This includes being kept, given away, destroyed, sold, or donated.

### **Payment**

- Consignment fees:
  - 25% for saddles and items over \$500
    - 20% for two or more saddles
  - 20% on items sold for \$101 \$499.99
  - 10% on items sold for \$1-\$100.99
- Upon sale of a consigned item, THA will issue payment within 14 days minus shipping and consignment fees.
- Payment options are: PayPal, Venmo, or Check.
